Section 3 Hazards Identification (continued)

Inhalation: Vapor concentrations above recommended exposure levels are irritating to the eyes and the respiratory tract, may cause headaches and dizziness, are anesthetic and may have other central nervous system effects, such as staggering gait, confusion, unconsciousness and coma

Eye: Irritating.

Skin: Frequent or prolonged contact may irritate and cause dermatitis.

Ingestion: Small amounts of the liquid aspirated into the respiratory system during ingestion, or from vomiting, may cause bronchiopneumonia or pulmonary edema.

Health Hazards (Acute and Chronic): Pre-existing heart disorders may be aggravated by exposure to this material.

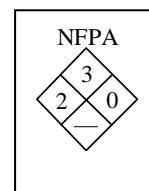

Section 6 Accidental Release Measures

Spill /Leak Procedures: Stop spill at source. Remove all sources of ignition. Use non-sparking tools. Dike area and contain. Clean up remainder with absorbent materials such as sand or vermiculite. Mop up and dispose of.

Section 7 Handling and Storage

Handling & Storage: Use with adequate ventilation. Avoid prolonged breathing of vapor. Avoid prolonged or repeated contact with skin. Wear safety goggles or face shield. Wear gloves, apron and footwear impervious to this material. Wash clothing before reuse. Store at ambient temperatures. Keep container tightly closed and upright when not in use to prevent leakage.

Ventilation: Local exhaust recommended. General mechanical is acceptable. Provide general or local exhaust ventilation systems to maintain airborne concentrations below OSHA PELs (Sec. 2).
